

What is the Indiana CHOICE Scholarship?

The Indiana CHOICE Scholarship was created to give as many Indiana families as possible the opportunity to select the right school for their child.

The CHOICE Scholarship achieves this goal by providing State-funded scholarships to eligible students that help to decrease the price of tuition at private schools.

The Indiana CHOICE Scholarship can significantly decrease the amount of tuition an eligible family pays annually.



How do I apply for the Indiana CHOICE Scholarship?

Eligible families will fill out a financial aid application packet after being accepted for admission to Saint Lawrence Catholic School.

Choice Scholarship Amounts

A CHOICE application can be submitted for accepted students that are financially eligible. The scholarship will not be awarded for more than the total of tuition (minus any discounts), activity fee and STREAM fee. It will not cover the registration or processing fees.

The amount of each scholarship varies depending on the school corporation in which the eligible family lives, as seen below:

CHOICE Scholarship Example

For a family of Saint Lawrence parishioners living in Lawrence Township that is eligible for a CHOICE Scholarship.

2023-24 Parishioner Tuition & Fees	\$6600.00
CHOICE Scholarship	- \$6450.00

Annual Tuition = \$ 150.00

That is just \$150 for a quality Saint Lawrence education!

Indiana CHOICE Scholarship Eligibility

To qualify for the Indiana CHOICE Scholarship Program, students must satisfy the following three criteria:

1. A student must:
 - a. Have legal settlement in Indiana
 - b. Be between the ages of 5 and 22 by August 1st; AND
 - c. Be accepted into a participating CHOICE Scholarship school.
2. A student must be a member of a household that meets the income eligibility criteria listed in the chart below.

3. A student must meet the requirements for ONE of the following eight tracks:

(Adapted from documents provided by the Indiana Dept. of Education*)

1. **Continuing Choice Track**
The student received a CHOICE Scholarship in the immediately preceding school year and remained enrolled at the participating school for the entirety of the immediately preceding school year.
2. **Previous Choice Track**
The student received a CHOICE Scholarship in a prior school year.
3. **Previous SGO Track**
The student received an SGO scholarship from an approved Scholarship Granting Organization in a previous school year.
4. **Special Education Track**
The student has a disability that requires special education AND an Individualized Education Plan (IEP) or Individualized Service Plan (ISP).
5. **"F" Public School Track**
The student is zoned to attend a specific school based on their residence that has been assigned an "F" grade.
6. **Two semesters in a Public School Track**
The student has been enrolled in grades K-12 in a public or charter school in Indiana for at least two semesters immediately preceding the first semester in the participating CHOICE school.
7. **Sibling Track**
The student has a sibling who received either a CHOICE Scholarship or an SGO Scholarship in a prior school year.
8. **Pre-K Track**
The student received and used an Early Education Grant to attend Pre-K at a participating school and is applying the CHOICE Scholarship to the same school.
